

was not allowed by the Director, Primary Education on the grounds that norms of fees was not got approved from District Primary Education Officer salaries being not paid by cheque through bank. For these grounds he has stated that Tuition Fee, Term fee and admission fee each Rs.75/- is being collected. For approval of these fees, an application dated 21/11/87 has been made. Representative of the District Education Officer has stated that necessary information in this respect is being sought for from the institute and matter regarding taking decision in this respect is under consideration by the office of the District Education Officer.

He has further stated that The Adhmedabad Education Society is very old educational institute in the city and it is registered as Public Trust in 1935. This society is running about 20 educational institutes in the Ahmedabad city. Thus, their institute is prominent institute. Salary to the teachers

are being paid by cheque through bank.

Necessary documents in this respect has been produced during the course of hearing.

From June-86 permission for standard 4 was required to be obtained gradually, but, institute has made application for classes of English medium for standard 4 to 6. For which permission from June-86, classes are being run without permission since June-86.

96 students in Class 4, 84 students in class 5 and 86 students in class 6 are studying.

Considering the above details, there appears grounds for granting permission for 2 classes each of English medium for standard 4 to 6 from June-87.

Permission has been granted for a classes each for standard 4 to to 6 and permission for 2 classes for standard 7 is to be granted. School is having facility of classes of sufficient area and also having play ground.

Tuition Fee, Term fee and admission fee each Rs.75/- is being collected. For approval of these fees, an application dated 21/11/87 has been made. Thereafter several reminders have been made from time to time.

Salary to the teachers are being paid as per the Government Rules by the institute through the bank.

He has further stated that, the institute has constructed new building having entire facility and classes have been started there. Along with permission for Primary Schools submissions have been made for permission for High School. So



that students can continue their study upto standard 10 without changing the school. Classes of standard 8,9 and 10 are running in this building. Classes of primary and high school are running at different time.

19 teachers have been appointed in school. All are trained graduates. Total number of students in the school is 687.

Considering the above details, in view of gradual development, there appears sufficient grounds to grant permission for 2 classes of English medium for standard 7.








(3) SCHEDULE-1

The recognized private primary school shall have to comply with the following conditions scrupulously. Recognition of the school failing to comply with condition shall be withdrawn at any time.

- (1) This Permission is granted under the Mumbai Primary Education Act, 1947 and under Sub Rule (4) and (7) of Rule-106 (a) of the amended Rules.
- (2) Administration of the school shall be conducted as per the orders and directions issued by the Education Committee from time to time.
- (3) Salary of the teachers and staff shall be in accordance with the Pay approved by the Government and shall be paid accordingly.



PADIA WIND TO THE TOTAL OF THE

4) School has to approve fees from the District Education Officer, fees to be collected from the students and shall have to collect fees as approved by the District Education Officer and to issue necessary receipts.

- (5) School shall not collect any other fees from the student except fee, term fee and monthly education fee.
- (6) School shall not be run for earning profit, Education Inspector of the school can inspect the audited accounts of the school.
- (7) For admission of the student, School of trust running the school shall not compel the parents of the student for any donation or loan.
- (8) Trust of the school board shall have to open account in the scheduled bank and



staff shall be paid salary by cheque through this bank account.

- (9) School shall have to follow the syllabus and subject as approved by the Government and shall not utilize any literature other than the study books as approved by the Government from time to time.
- (10) Trust or Board running the school cannot change the administration. Any change without prior approval shall be considered as unauthorized and liable to cancellation of recognition automatically.
- (11) Without prior permission, no change can be made in the building of the school or place of school for which permission is granted and in the case of change without prior approval, recognition shall stands automatically cancelled.




(12) School shall have to be started from the the year itself for which permission has been granted. If the school is not started within six months from the date of permission then permission shall stand cancelled automatically.


