**::: READ :::**

(1) Proposal for the **academic year 2026-27** has been submitted by A.E.S.- A.G. School, Opp. Dada Saheb Flat, University Road, Navrangpura, Ahmedabad – 380 009 run by The Ahmedabad Education Society for Secondary Section - Std.10<sup>th</sup> (CBSE – English Medium) along with relevant documents.

(2) FRC has considered final order dtd. 30.12.2024 passed by the FRC for the academic year 2024-25 for Pre Primary and Primary Section **AND** provisional order dtd. 17.04.2025 passed by the FRC for the academic year 2025-26 for Secondary Section (Std.9<sup>th</sup>) (CBSE – English Medium).

(3) Proposal discussed in the FRC on 17-02-2026.

**::: Provisional Order :::**

Date of order: 02.03.2026

(1) A.E.S. - A.G. School, Opp. Dada Saheb Flat, University Road, Navrangpura, Ahmedabad – 380 009, has filed its proposal for Academic Year 2026-27 for Secondary Section - Std.10<sup>th</sup> (CBSE – English Medium) along with relevant documents. We have gone through the papers submitted along with proposal. The School has produced Audit Reports for the years: 2023-24 and 2024-25. The School has produced provisional Income & Expenditure Account Statement for the year: 2025-26 and projected Income & Expenditure Account Statement for the year: 2025-26 and 2026-27.

(2) FRC has considered section 10(3) of “The Gujarat self-financed schools (Regulation of fees) Act. 2017”, which is reproduced as under.

The fee regulatory committee shall determine the total fees which shall be levied by considering all different fees charged by the school.

(3) The FRC is required to exercise the power conferred upon it in a very balanced manner so as to see that on one hand the school management is not deprived of the legitimate fees to be charged from the students and the students also should not suffer by paying exorbitant fees charged by the Self-Financed School. The object of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017 is to prevent “**profiteering**” which is defined in Section – 2 (r).

(4) Looking to the Audited Income & Expenditure Account Statement for the A.Y: 2023-24, 2024-25 and on verifying the same statements it is found that some of the expenses like Employees Health Insurance Premium Exp., Employees Life Insurance Premium Exp., Employees GPA Insurance Premium Exp., Supplementary Exp., Annual Function Exp., Examination Exp., Freeship Exp., Sports Exp. Prize Distribution Exp., Festival celebration Exp., Building Repairs Exp., Refreshment Exp., Traveling Exp. and Maintenance Exp. etc. are either higher sides and or not justifiable because they are either excess or without explanation and not for education purpose. And also considering the strength of the student's it is found that the proposed fee structure is not found satisfactory. But looking the teacher's salary some reasonable fee structure determines by the FRC.

The FRC has also considered pupils and teachers ratio by considering the schedule provided under the RTE Act.

(5) In light of foregoing views and reason advanced herein above and the above facts and audited account Statements as well as considering reasonable revenue surplus for the purpose of development, education and expansion of the School, We determine the provisional fees as under.

The FRC has also considered the fees determined order passed, for the school for Standard Pre Primary Section to Secondary Section (Std.9<sup>th</sup>) which is passed up to A.Y: 2026-27, there for considering the conveyance of the school the FRC has decided to determine the fee structure for standard Secondary Section (Std. 10<sup>th</sup>)for 1 year i.e. 2026-27 only. There for the school has to submit its single proposal for all the standards conducted by the school for the year: 2027-28.

The School is directed to charge this determined fees according to the definition of fee or fee structure given in section 2(g) of the Gujarat Self-financed schools (Regulation of fees) Act.-2017. In view of the order passed by Hon'ble Supreme Court of India in SLP (Civil) Diary No. (S)17802/2025 on Dtd.: 29.07.2025 the School shall not demand any amount more than that which is fixed by the FRC.

**:: Terms and conditions ::**

- (1) The School shall not collect fees amounting to more than one quarter at a time.
- (2) It is made clear that as per Sub rule (4) of Rule 7 of the Gujarat Self-Financed Schools (Regulation of Fess) Rules, 2017, the FRC has determined the total fees under a single head which may be levied or collected by the school. Therefore the school is permitted to collect fees as per to the definition under section 2(g) of the Gujarat Self-Financed Schools (Regulation of Fess) Act, 2017 **However, total of these fees shall not exceed the total fee determined by the committee as per the above mentioned table.**
- (3) It is also made clear that the school should either return the excess fee collected by the school or give adjustment thereof, in the fees in the next coming academic year without fail.




(4) It is directed that the school is not permitted to collect fees for the any year, more than the provisional fees determined by the FRC for the above years, except permissible.

(5) Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.

(6) If the school is aggrieved by the provisional fees determined by the committee, the school has a right to file objections before the committee within 7 days from the date of receipt of this provisional order.

(7) The School is directed to place the provisional order determining the provisional fees on its notice board as well as on its website in English and Gujarati language.
